SOUTH JETTY UPDATE.

Moving forward. Correspondence from Ray Buchegar, \$12.4Mil request did not make the final package. TW placing stone started July 25. Jepson coordinating with OIPCB and TW regarding the dredge outflow pipe and placement.

ABANDONED/DERELICT VESSEL AND MOORAGE CONCERNS.

Most paperwork done for DEQ for F/V Hawk. Sampling is done. Looking at approximately \$12k for disposal. Good communication happening with DSL. F/V Breanna is sitting in Crab Harbor. May look at working with TCSO for the seizure and disposal of F/V Breanna. Richland Star is coming back in.

GRANTS UPDATE.

Still waiting on word for PIDP. Meeting with Folkema before lunch on August 26th. Discussion about cold storage and if the need is still there for it. Most offered privately and may be enough for Garibaldi.

EVENTS UPDATE.

Oregon Tuna Classic is coming next week. Jacquie Roar and Seafood & Spirits festival coming up. Ashley Christensen is organizing Seafood & Spirits this year.

LEASE UPDATE.

L-15 Garibaldi Marina is in process. L-32 Ambulance quarters is looking at renewing for 5 years. R-Sanitary is having issues with parking and people dumping. No answers

currently, but looking for long term solutions. Taking over Quonset hut next month. Frees up the current port shop.

HAZ-MIT PLAN.

Nothing new.

ODOT 101 PROJECT/RAIL CROSSINGS.

Ready to go.

BOAT BASIN DREDGE PROJECT.

Work window is November 1 to February 15. May look to request work window adjustment. Regardless OIPCB is looking to stage starting September 15th. Coon was able to get finished legal opinion letter to OBDD.

NEW BUSINESS

MANAGER EVALUATION.

Motion Perez, second by Cavitt to approve contract renewal with a 4% COLA and 3% merit increase. Motion carried 3 - 0.

STAFF REPORTS

Saindon noted helped City of Garibaldi Public Works candidate interviews.

Looking into mechanical harvesting of shellfish ban that staff is hearing about. Frustrated with how little transparency there is. Tillamook County Commissioners have not even heard about this, nor had Sen. Weber. Saindon noted will continue looking for answers.

L-02 Red building dock is getting worse. Rate of failure increasing rapidly.

City has street signs in the works.

COMMISSIONER CONCERNS

Perez – None. Folkema asked Perez if there is a good time to meet. Perez noted has an ongoing case will be leaving to Mexico.

approaching the Oregon State Insurance board. May look at lobbying before it all comes down. Folkema noted to look at Kyllos in Lincoln City. Folkema asked Saindon to bring this up with his meeting with Bell and Weber. Discussion about the board of realtors issues happening. Insurance may really affect the bottom line.

Folkema – asked about the sailboat and the seagull nest. Gone and taken care of. Red building; tried doing Brownsfield. Folkema noted hoping to get help with getting bar reports. Currently USCG is not putting a bar report out until 9am, after everyone is already out on the water. Not a problem now, but may become one. Saindon noted trying to get the new station command to attend an upcoming meeting. Discussion about having Mark Landauer survey the other ports to see how insurance rates are rising among the ports. A consumer protection issue.
